## Membership Categories:

### Regular Membership

Full Clubhouse access  
Parking permit\*  
Right to vote and hold office  
One burgee

### Family Membership:

Two regular members  
Junior members of their immediate family  
One parking permit\*  
Right to vote and hold office  
One burgee

### Junior Membership:

Person under 21 years of age sponsored by a regular member. A Junior member is excluded from the right to vote and hold office.

### Cruising Membership:

Member in good standing that will be out of state for an extended period of time and has the intent to return to Alaska and to full membership.

### Race Crew Membership:

A Race Crew member is a non-boat owner sponsored by a Regular member. The Race Crew member receives use of the Club facilities on scheduled race weekends. Excluded are the right to vote, hold office, and a parking permit.

### Live-aboard Membership:

A live-aboard member is defined as a member who uses Club facilities more than 14 days in a row. Such use will be assessed a surcharge of \$10/week per member. Please sign in weekly in the member log book in the clubhouse. Estimated payment should be included with dues; additional payment should be mailed to WHSYC, PO Box 90341, Anchorage AK 99509.

Long term guests: Members of reciprocal yacht clubs are considered guests sponsored by the William H. Seward Yacht Club for a period not to exceed 14 days. After 14 days, a fee of \$20/week will be assessed for use of Club facilities.

Use of the Clubhouse facilities is limited to Regular members, Cruising members, Junior members, and Live-Aboard members in good standing.

It is not necessary to own a boat to become a member. All memberships are awarded at the discretion of the Board of Directors.
